

# Privacy Policy

In light of the new EU General Data Protection Regulation 2016/679 (GDPR), which will take effect on 25 May 2018, we set out below certain information about the data we process in order to communicate with you.

Day One Capital Kockázati Tőkealap- Kezelő Zrt., (1123 Budapest, Alkotás utca 53., Cg: 01-10-046845) (Day One Capital) is the controller of your data which means that we are responsible for how your data are collected and used. We respect your privacy and will protect any of your personal data that we process. All personal data are processed in accordance with applicable data protection laws.

## I. Voluntarily provided data

### The types of data we collect

We collect certain personal data about you. “Personal data” is data that can be used to identify you or that we can otherwise link to you using information we may already hold.

We collect personal data that you voluntarily provide to us, for example when you choose to submit a CV or a business plan to us via email or to sign up for our monthly newsletter. The data we collect includes your name, the name of your employer, postal address, contact phone numbers, e-mail address and job title.

### How we use the data that we collect and store

We use the personal data we collect for communication purposes, including:

- To conduct our regular business that is investing in and supporting portfolio companies;
- To send you invitations to our newsletter and related events;
- To maintain our list of business contacts.

We do not sell, hire out, distribute or otherwise make your personal data available to any third party. However, we may share information with our suppliers for the purposes listed below.

### Our basis for using your personal data

When processing personal data for the purposes explained in this notice, we do so for the purposes of delivering our contracted services to you or for maintaining our business relationship with you. In addition, where we may provide you with details of other services which we believe may be of interest to you, we rely on our legitimate interests in maintaining business relationships and/or communicating with you as an existing client for similar services.

### How we may share the data we collect

Only employees of Day One Capital may have access to your personal data for the purposes mentioned above. In addition, Day One Capital use the services of Data Processors (see below) to process and handle the data.

### **How long we will keep your personal data**

Your personal data will be saved for the specified purposes mentioned above for as long as you do not explicitly express your intention to withdraw your consent or to delete your personal data.

### **Your choices and rights**

We welcome your inquiries and comments. You have the right to know what personal data we process about you and may request a copy. You are also entitled to have incorrect personal data about you corrected and you may in some cases ask us to delete your personal data. You can also object to certain personal data about you being processed and request that processing of your personal data be limited. Please note that the limitation or deletion of your personal data may mean we will be unable to provide the communications and invitations described above. You also have the right to receive your personal data in a machine-readable format and have the data transferred to another party responsible for data processing.

If you are dissatisfied with how we process your personal data, you are entitled to report this to the Hungarian National Authority for Data Protection and Freedom of Information (NAIH), which is the Hungarian regulator for the processing of personal data.

### **Security measures to keep your personal data safe**

Day One Capital acknowledges that the information you provide may be confidential and will maintain the confidentiality of and protect your information in accordance with its normal procedures and all applicable laws. We employ appropriate technical and organisational security measures to help protect your personal data against loss and to guard against access by unauthorised persons.

## **II. Data related to website usage**

### **Types of data we collect**

When you access our website or contact us via the website, we may collect information about your visit and your web browsing. That information may include your IP address, your operating system, your browser ID, your browsing activity, and other information about how you interacted with our Website. This information is not identifiable. This data is only accessible by Day One Capital and the data processors.

Some parts of the site may use a 'cookie,' which is a small text file that is placed on your computer's hard drive. The cookie collects standard internet log information and visitor behaviour information.

### **How we use the data that we collect and store**

We collect information via our website or contact us section as it will help us understand how our site is used and helps us provide the best service to those who use it.

### **Option to switch off cookies**

The site may use a cookie to collect which pages you visit or to provide you with enhanced capabilities during your visit. You can set your browser to refuse to accept cookies; however, if you choose to do this, some features of this site (and others) may not function properly.
